Tree Crops: Apply 2-4 pts per 100 gallons water. Spray to wet.

Application Volume:

Standard Ground: Use at least 40-100 gallons of low-salt water per acre.

Dilute / Hand spray: Use at least 40-100 gallons of low-salt water per acre.
